the Basketball, Softball, Volleyball, Kickball and/or Dodgeball games organized and sponsored by the Landau Lawyers League in the County of Los Angeles, the Undersigned hereby voluntarily releases, discharges, waives and relinquishes any and all actions or causes of action for personal injury, property damage or wrongful death occurring to the Undersigned arising out of the participation in said sport or any activities incidental thereto wherever or however the same may occur and for whatever period said activities may continue, and the Undersigned does for himself/herself, his/her heirs, executors, administrators and assigns hereby release, waive, discharge and relinquish any action or causes of action, aforesaid, which may here-after arise for himself/herself and for his/her heirs, executors, administrators or assigns shall not present or prosecute any claim for personal injury, property damage or wrongful death against the Landau Lawyers League, the Lawyers League Management Corporation, the Los Angeles Unified School District, and the City of Los Angeles Department of Recreation and Parks on any of their officers, agents, servants, employees or officials (hereinafter referred to as "Releases") for any of said causes of action whether the same shall arise by the negligence of any of said persons or otherwise.

The Undersigned acknowledges, understands and assumes the risks inherent in Basketball, Softball Volleyball and/or Kickball and understands the said sports entail risks to his/her person and property and the Undersigned is participating with full knowledge of said risks.

The Undersigned acknowledges, understands and assumes the risk, if any, arising from the conditions of the various basketball, volleyball and kickball courts, softball fields and adjacent school or park grounds and parking lots and acknowledges and understands that the included within the scope of said waiver and release is any action or causes of action arising from the performance, or failure to perform, maintenance, inspection, supervision, control or security of said areas and for the failure to warn of dangerous conditions existing on or near said locations or for any action or causes of action for negligent supervision or selection of officials, spectators, players or coaches.

The Undersigned, for himself/herself, his/her heirs, executors, administrators or assigns agrees that in the event any claim for the Undersigned's personal injury, property damage and/or wrongful death shall be prosecuted against releases he/she shall indemnify and save harmless releases from any and all claims or causes of action by whomever or wherever made or presented for the Undersigned's personal injuries, property damage and/or wrongful death.

I have read and hereby agree to abide by the PLAYERS CODE OF CONDUCT. I further acknowledge that my participation in the LANDAU LAWYERS LEAGUE will be in jeopardy should I fail to adhere to this code.

I grant to the Landau Lawyers League and its representatives/affiliates the right to take photographs of myself and spectators, with or without my knowledge. I authorize the LLL to copyright, use and publish the same in print and/or electronically. I agree the Landau Lawyers League may use such photographs of me and my spectators with or without my name and for any lawful purpose, including publicity, illustration, advertising and web content.

It is understood that I cannot play in the league until this WAIVER form has been completed. An e-mailed copy of this waiver is legal.
